Please make sure that your health insurer will fully cover the costs for medical treatment in Switzerland, the reimbursement is not limited to the tariffs of your country of residence and the free choice of service provider under Swiss law is guaranteed.

Information sheet for border workers and their non-employed family members concerning compulsory health insurance in Switzerland Canton Basel-Stadt

Since the bilateral agreements between Switzerland and the EU and its member states regarding the free movement of persons have taken effect, border workers and their non-employed family members (spouses and children) are subject to the regulations governing compulsory health insurance in Switzerland. If the spouse is working in the country of domicile, he/she as well as the children are subject to the legal regulations of their country of domicile. In this case they do not have to be mentioned on the registration form.

Border workers from neighbouring states (**Germany, France, Italy or Austria**), have the possibility to request an exemption from the compulsory health insurance in Switzerland, providing they can prove that they have adequate cover in their country of domicile and in Switzerland. This option has to be taken up **within three months of the date of validity of the border workers permit**. Further, the option can only be chosen **once**. Border workers from other countries do not have this option and are subject to the compulsory health insurance of Switzerland. The list of current premiums can be found under www.priminfo.ch (Prämienübersicht EU/EFTA).

The Cantons are responsible for controlling compliance in respect of compulsory insurance. The above-mentioned Canton has delegated this task for administrative reasons to the Gemeinsame Einrichtung KVG in Olten. This institution is entitled to request all necessary information and documents from you. As a federal organ it is subject to the Swiss regulations on data protection. Please find further information under www.kvg.org.

To enable us to check your insurance position respectively the exemption from the compulsory health insurance, we would like to ask you to send us the following documents:

Health insurance in Switzerland

- completed registration form
- copy of your current insurance policy (with EU/EFTA premiums)
- copy of your border worker's permit

Exemption from the compulsory health insurance

Legal insurance in the country of residence:

- completed registration form
- Valid proof of insurance
- copy of your border worker's permit

Private insurance in the country of residence:

- completed registration form
- current confirmation of your health insurance
- copy of your border worker's permit

Please also enclose copies of current insurance policies for each non-active family member.
